E-METER PURCHASE CONTRACT

1. I, \_\_\_\_\_, acknowledge that the scriptures of the Scientology religion delimit the use, possession, and ownership of the Scientology religious artifact known as the Hubbard Electropsychometer or E-Meter.

2. I further acknowledge that use, possession, and ownership of an E-Meter is limited exclusively to: (a) duly ordained ministers of the Scientology religion; (b) Scientology auditors; (c) Scientology word clearers; (d) Scientology ethics officers; (e) Scientology course supervisors; (f) Scientology cramming officers; (g) Scientology examiners; (h) persons actively engaged in training to become a person identified in (a) through (g), above; and (i) persons who are graduates of or are actively engaged in religious training on the Hubbard Professional E-Meter Course.

3. I covenant, warrant, and represent that I qualify to use, possess, and own an E-Meter in that I am a \_\_\_\_\_.

4. I further acknowledge and agree that the E-Meter is a religious artifact used in delivering Scientology religious services to parishioners and that E-Meters shall be used, sold or distributed only for use in bona fide Scientology religious counseling. I further acknowledge and agree that the purpose of the E-Meter is exclusively religious and that Church of Scientology International ("CSI") is responsible for making E-Meters available for use only in accordance with Scientology's scriptures.

5. I further acknowledge and agree that an E-Meter is to be used only for religious purposes, that by itself, it does nothing, and that its use is limited exclusively to helping parishioners locate precise areas of spiritual difficulties. I further acknowledge and agree that an E-Meter is never to be used in any medical or physical treatment or in the diagnosis, treatment, or prevention of any disease or condition, and that its use, possession, or ownership by any unqualified person, including but not limited to doctors, scientists, psychiatrists, and psychologists, is strictly forbidden.

6. By this E-Meter Purchase Covenant, I hereby state my intention to purchase, and my agreement to use, possess, and own an E-Meter, which I covenant and agree to use, possess, and own in strict accordance with the scriptures of the Scientology

religion and in strict accordance with the following covenants, promises, representations, and conditions:

- a. I will only use the E-Meter for the purposes of the Scientology religion and only as described in the scriptures of the religion;
- b. I will only use the E-Meter for those religious functions on which I have been fully and properly trained and I further undertake to become wholly skilled in its purpose and use;
- c. Should I cease to be a Scientologist in good standing or lose my ministerial ordination or other ecclesiastical authorization to operate an E-meter, I will cease and desist all use of the E-Meter until I once again qualify to use the E-Meter pursuant to the scriptures;
- d. I shall not sell or otherwise transfer ownership of any E-Meter in my possession, custody, or control to anyone who does not qualify to use, possess, or own an E-Meter under the doctrines set forth in Scientology scripture and who has not executed a covenant identical in form and substance to this Covenant;
- e. Should I ever intend to sell my E-meter, I will first notify the Church in writing so it may, if it so chooses, purchase the E-meter back from me; and
- f. I shall not offer or advertise any E-Meter for sale at any time.
